SUBJECT: Crime Statistics from October 1, 2016 - January 31, 2017

In accordance with New Jersey Statute P.L. 2015, Chapter 220, S485, supplementing Chapter 3b of Title 18A, enacted on January 19, 2016, the president of each public institute of higher education shall report to the governing board of the institution, at each of its regular meetings, all crimes, fires and other emergencies which occurred on campus during the previous reporting period. For the purposes of this report, The College of New Jersey is following the Clery Act definitions for reporting crime statistics.

- Arson- 0 incidents
- Burglaries- 4 incidents
- Hate Crimes- 0 incidents
- Drug Law Offenses- 8 incidents
- Liquor Law Offenses- 23 incidents
- Driving while Under the Influence or Intoxicated- 0 incidents
- MV Theft - 4 incidents (4 golfcarts/all recovered)
- Sexual Assault- 2 incidents
- Dating Violence - 0 incidents
- Fire Statistics - 0 incidents
- Other Emergencies – 4 timely warnings issued during this period

**\*\*NOTE:** The numbers reported reflect the number of occurrences, *not* the number of victims.



## **Resolution Concerning Implementation of Increase In Compensation For The President of The College of New Jersey**

Whereas: The College of New Jersey Board of Trustees is authorized under the provisions of N.J.S.A. 18A:64-6 to “appoint and fix the compensation of a president of the college, who shall be the executive officer of the college”; and

Whereas: The President's salary has remained unchanged since her last increase effective July 1, 2015; and

Whereas: The College of New Jersey Board of Trustees conducted a comprehensive annual performance evaluation of the President and found her performance to greatly exceed expectations. Specifically, under President Gitenstein’s leadership, the institution finalized the development of a strategic plan which speaks to the College’s role in meeting the challenges of the higher education landscape, the enterprise risk management program has been further advanced and is addressing the mitigation of risks across the institution. She continues to be a leading voice for higher education on the national level through her leadership on a variety of boards, including the American Council on Education; and

Whereas: Most significantly, President Gitenstein’s leadership has led to an extraordinarily successful comprehensive capital campaign. The campaign’s goal of 40 million dollars was reached a full six months ahead of schedule, allowing a new goal to be established, encouraged by Dr. Gitenstein, of 45 million dollars.

Whereas: The Board recognizes President Gitenstein’s thoughtful, effective leadership as she enters her 19<sup>th</sup> year as the president of The College of New Jersey; and,

Whereas: In reviewing the president’s performance the Board considers her exceptional service and the current market to ensure that her compensation is consistent with her peers in the state.

That The College of New Jersey Board of Trustees, authorizes a 3 percent increase for the president effective July 1, 2016 and, in recognition of her accomplishments with regard to the comprehensive capital campaign, authorizes a one-time bonus of 5 percent to be awarded at the end of the campaign, June 30, 2017.

**Resolution Honoring Dr. Morton Winston  
for Service to  
The College of New Jersey Board of Trustees**

- Whereas:** Dr. Morton Winston was elected by his faculty colleagues to serve as Faculty Representative to the Board of Trustees in 2015; and
- Whereas:** During his time on the Board Dr. Winston served as a member of a number of Board committees including, College Advancement, Finance& Investments, Student Life and Business and Infrastructure, providing wise counsel and essential perspective on all matters under consideration; and
- Whereas:** Dr. Winston joined TCNJ's faculty in 1992, developing and teaching courses on bioethics, genocide and human rights, environmental ethics, human rights in international relations, human rights, philosophy of technology, and mind, language and computers. He served as chair of the Department of Philosophy from 1982-1988 and again from 2005 to 2012; and
- Whereas:** Throughout his tenure at the College, Dr. Winston was an institutional leader having served as co-chair of the Committee on Strategic Planning and Priorities, and led the development of TCNJ's strategic plan in 2011-12; and
- Whereas:** During his years as an academic, Dr. Winston led both the academic and the TCNJ communities in discussions of the substantive questions at the core of the academic enterprise and the mission of The College of New Jersey; and
- Whereas:** Dr. Winston was an internationally recognized human rights scholar, educator, and activist. He edited one of the first widely used textbooks on the philosophy of human rights in 1989. In 2007 he held the Danish Distinguished Chair of Human Rights at the Danish Institute of Human Rights in Copenhagen. In addition to this senior Fulbright Scholarship he received two other Fulbrights in South Africa in 1992 and Thailand in 1999; and
- Whereas:** Dr. Winston's passion for international human rights led to his election to the national Amnesty International board of directors in 1991, and later as chairman of that board from 1995-1997 and again in 2002. His work with Amnesty International broadened the scope of the organization's mission and enhanced the impact of their work, worldwide; and
- Whereas:** Dr. Winston was inducted into Phi Beta Kappa in 1970 (Epsilon of Pennsylvania – Swarthmore College) and was a founding keyholder of TCNJ's chapter. He was selected by his fellow keyholders to deliver the chapter's inaugural induction ceremony address in April 2006, and had been serving as the chapter's treasurer; and
- Whereas:** Dr. Morton Winston died in January 2017 while on vacation in Peru with his wife, Sally; and
- Whereas:** The members of The College of New Jersey Board of Trustees, his faculty and administrative colleagues, and his current and former students, celebrate Dr. Winston as an essential contributor to our campus community and the world and express our deepest condolences to his wife, Dr. Sally Winston and his daughters Maggie, Molly, and Carla;

## **The College of New Jersey Resolution Approving Student Fees for Pre-College Academy Series (Summer Program) 2017**

- Whereas:** The State College Autonomy Law vests the responsibility with the Board of Trustees to approve and adjust student charges as necessary; and
- Whereas:** In April 2016, the Board of Trustees approved the TCNJ 2021: Bolder, Better, Brighter strategic plan that articulated five strategic priorities in order to guide the implementation of institutional strategic goals; and
- Whereas:** These strategic priorities include specific goals to identify and implement creative options for revenue enhancement and to communicate TCNJ's identity to new target audiences; and
- Whereas:** Faculty of two Schools – Science and Health and Exercise Science – in collaboration with the Office of Graduate and Advancing Education have created a series of 2 two-week and 1 one-week summer pre-college academies in the fields of Ecology, Physics and Health Science; and
- Whereas:** These pre-college academy series will not be offered for academic credit, but serve to give early exposure and career exploration opportunities to rising 9<sup>th</sup> and 10<sup>th</sup> graders; and
- Whereas:** These academies will introduce their participants to college experience, research, labs and full time faculty, and potentially recruit them as future TCNJ students; and
- Whereas:** The Provost recommends student fees of standard rate of \$1,900 and faculty/staff dependent rate of \$1,700 for the two-week program, and a standard rate of \$950 and faculty/staff dependent rate of \$850 for the one-week program; and
- Whereas:** The President has reviewed the proposed student charges required to implement pre-college academy series in summer 2017 and recommends their approval; and
- Whereas:** The Business and Infrastructure Committee of the Board of Trustees has reviewed the student charges required to implement pre-college academy series in summer 2017 and has recommended their approval.
